

OPERATIONAL FOOTPRINT

Our delivery model is built around Brazil's major shipping corridors and port ecosystems—including Santos, Itaqui, Paranaguá, Rio Grande, Cabedelo, and Vila do Conde/Barcarena—with additional ports supported subject to feasibility and local requirements.

Ship agency and port clearance support delivered with disciplined documentation control and practical responsiveness.

Our focus is "execution discipline": clear communication, document control and transparent reporting that protects schedule and reduces misunderstandings around port procedures and disbursements.





CARGO HOLD CLEANING (BULK CARRIERS)

CARGOWARD® provides cargo hold cleaning in Brazil for bulk carriers and general cargo vessels calling Santos, Paranaguá, Vitória and Itaqui, as well as other ports available in our operational request form. We deliver a controlled, cargo-driven scope aligned to your next cargo, port constraints and the readiness expectations commonly applied by terminals, charterers and surveyors.



This service is built around operational outcomes—not generic wording. Depending on hold condition and target standard, our scope may include chemical-assisted cleaning using proven products (e.g., AquaTuff or equivalent), residue removal and wash-down, de-rusting / surface preparation, and—when required to reach the agreed target—touch-up coating or repainting of defined hold areas. Work is planned hold-by-hold with practical checkpoints and a documented close-out package.



TANK CLEANING & SLUDGE DISPOSAL (HFO/VLSFO)

When HFO/VLSFO tanks start causing operational friction—sediment build-up, wax/asphaltene deposits, transfer restrictions, unstable heating/viscosity control—waiting is usually what makes the next port call harder. CARGOWARD® provides fuel tank cleaning in Brazil with a practical, engineered approach: scope definition first, controlled execution next, and a documented close-out at the end.

Our engineering team and chemical engineering team define the cleaning logic (residue type, compatibility, sequence, risk controls). The shore gang executes the operation under shipboard safety management, with clear checkpoints and waste-stream discipline. Where the port workflow requires it, we coordinate slops/sludge reception and disposal interfaces with approved facilities and the relevant documentation trail (port-dependent).






UNDERWATER HULL INSPECTION & CLEANING

CARGOWARD® provides underwater services in Brazil for trading vessels that need measurable results within a port call window. Our certified divers operate with shore-based coordination and a technical reporting mindset: every job is scoped by area, executed with clear limits, and closed with organized evidence.

We support two common objectives:

1. Understand condition (inspection with verifiable photo/video), and/or
2. Improve underwater condition (biofouling removal, propeller polishing, rudder/appendage detailing, sea chest cleaning where feasible).

When stakeholders request class-facing documentation, we can structure outputs to match the style typically expected for review under DNV, ABS and BV practices (scope-dependent).



HOW WE DELIVER (OPERATING MODEL)

A consistent operational logic

Across services, we run jobs by: **scope definition → controlled execution → evidence capture → close-out package**, keeping delivery auditable and reducing ambiguity between requested vs. performed work.

Typical controls & records (as applicable per scope)

- Method statement / work plan, risk controls (e.g., JSA) and toolbox briefings
- Permit-to-work coordination and shipboard safety management interfaces
- Waste-stream discipline and traceability documentation (port-dependent)
- Photo/video evidence organized by zones + close-out notes
